SECTION 3 – AFFIDAVIT OF ELIGIBILITY

3.1 In order to be certified as eligible for appointment to a City Board or Commission position, I understand the Saginaw City Charter requires that I am not in default¹ to the City of Saginaw.

3.2 I have been advised that default is defined as when the City of Saginaw has placed an individual on notice that monies are due and owing and the individual has not entered into a payment plan with the City. Failure to file yearly income tax returns or file an Income Tax Affidavit for taxable income under \$1,000.00 is considered to be in default². A debt that is subject of an administrative appeal or contested court case is not considered to be in default.

3.3 I hereby certify by my signature below that I am not in default to the City of Saginaw for any obligation due and owing including, but not limited to, parking tickets, water bills, income taxes, property taxes, or other assessments owed to the City of Saginaw. I certify that, if required to do so, I have filed all yearly income tax returns or filed an Income Tax Affidavit for taxable income under \$1,000.00. If there is an outstanding obligation to the City of Saginaw, I have entered into a payment plan to satisfy the debt or the debt is the subject of an administrative appeal or contested court case.

3.4 I hereby certify that I have not been convicted of any felony other than those listed below or in a sheet attached to this Affidavit.

3.5 I hereby certify that if I have served on a City Board/Commission for the past three (3) years, I have not had more than three (3) unexcused absences for each calendar year.

3.6 In connection with my application to be appointed to a Board or Commission, I hereby authorize without reservation, the City of Saginaw through its employees, officers, or agents to investigate and deliver the information regarding the above to the City Manager's Office, to determine my eligibility for a Board or Commission position. I hereby waive any and all rights, claims, causes of action, or damages, which I may have against the City of Saginaw, its employees, officers, or agents in furnishing of any such record or information.
