

INDEMNIFICATION AGREEMENT

I, _____ agree to defend, indemnify, and hold harmless the City of Saginaw, a Municipal Corporation from any claim demand, suit, loss, cost of expense, or any damage which may be asserted, claimed or recovered against or from the City of Saginaw by reason of any damage to property, person property, person injury, or bodily injury, including death, sustained by him/her and which damage, injury, or death arises out of or incident to or in any way connected with the use and occupancy of the Queen Street Dump and/or its premises and legally described as:

“A parcel of land in N.W. frl. ¼ of Sec. 35, T.12N., R.4 E. viz. Comg. at intersection of N. line of Florence St. & Ely. Line of West Center St., thence E. on said N. St. Line of W. U.S. Harbor line of Saginaw river, thence Nly. along said line to a point on a line that is parl. to & 193 ft. Sly of S. line of Blk. 95 H.L. Miller’s Addition extended Ely., thence Wly. along said line, to a point that is 864.63 Ft E. line of Queen St., measured along said parl. Line, thence Sly. Perpendicular to said parl. Line, 272.33 ft., thence Wly. Pal. to said line, 406.5 ft., to E. line of West Center St., then S. Ely. along said St. line to point of beg.”

And regardless of which claim, demand, damage, loss, cost of expense is caused in whole or in part by the negligence of the City of Saginaw, or by third parties, or by the agents, servants, employees or factors of any of them.

REGULATIONS FOR USE OF QUEEN STREET

1. There will be no dumping of brush, trash, or other debris in the facility.
2. Lock gate after entering and upon leaving the facility. Gate must remain locked while you are inside the facility.
3. Permission is granted to person identified in this form only. Always use the vehicle listed herein. No lending out the key.
4. Any altercation with anyone will result in loss of your privileges.
5. **Immediately Report To The City Of Saginaw Streets Office The License Number Of Anyone Dumping In The Facility. Do Not Approach Anyone, Report Abuse To The Office. (989) 759-1695**
6. Any violation of these regulations will result in loss of privileges for 1 year for first offence, 10 years for second offence, and permanent loss with third offence.
7. Annual administrative fee of \$5.00 will be charged for valid permit from April 1st to March 31st. Permit must be renewed every year.
