Manager's Recommendation:

I recommend that payment be made to Jack Doheny Supplies, Inc. in the amount of \$6,188.90 for emergency repairs to the Public Services Department Right of Way Division's Sewer Jet.

This vendor meets all requirements of the Contract Compliance Provisions, Title 1, Chapter 14, §14.35 – 14.44, of the Saginaw Code of Ordinances.

Funds for these repairs are available in the Sewer Account 590-4821-861.80-42.

Justification:

The Right of Way Division's Vactor Truck #837 required repairs of external weldments on the debris tank. This work was beyond the scope of in-house personnel and required the services of the vendor who originally sold us the unit and specializes in repairing this type of sewer cleaning equipment.

Subject: Emergency Purchase For Chlorine Leak Detection System Parts

Manager's Recommendation:

I recommend that payment be made to Waterworks Systems and Equipment Inc., Lakeland, Michigan, in the amount of \$3,750.00.

This vendor meets all requirements of the Contract Compliance Provisions, Title 1, Chapter 14, §14.35-14.44, of the Saginaw Code of Ordinances.

Funds for this work are available in the Water Treatment Repairs and Replacements Account No. 591-4730-861.97-20.

Justification:

An emergency purchase order was issued to Waterworks Systems and Equipment, Inc., in the amount of \$3,750.00, to replace equipment that has failed or was due for replacement. This equipment is critical to the proper and reliable function of the chlorine gas leak detection and alarm system at the Water Treatment Plant. The equipment consists of chlorine sensors and a logic board. The chlorine sensors have a short shelf life. A short in the system caused the in service and back-up logic boards' failure. We located the short and repaired and replaced the affected equipment.

Manager's Recommendation:

I recommend that the quote from CMP Distributors, Detroit, MI be accepted and a purchase order be issued to them in the amount of \$2,000.00 for the purchase of duty and practice ammunition, due to the inability of the original sole bidder, Michigan Police Equipment Co., Charlotte, MI to comply with a timely delivery schedule.

This vendor meets all requirements of Contract Compliance Provisions, Title 1, Chapter 14, §14.35-14.44, of the Saginaw Code of Ordinances.

Funds for this purchase are available in the Police Administrative Services Supplies / Parts and Supplies Account No. 101-3012-721-7330.

Justification:

In August of 2006, Michigan Police Equipment Co. was awarded a bid for the purchase of duty and training ammunition for the Saginaw Police Department's range. The delivery term on the bid was four (4) weeks. Michigan Police Equipment shipped three of the six items in September of 2006. Numerous calls were made to Michigan Police Equipment Co. inquiring about the remaining items, which has not been received to date.

Due to the inability of Michigan Police Equipment Co. to comply with a timely delivery schedule, and the fact that the ammunition is needed for upcoming training, we are requesting to purchase the remaining items from CMP Distributors. The quote from CMP Distributors has been received and reviewed by the Purchasing Committee.

Justification:

On August 23, 2005, the City Planning Commission held a public hearing regarding the platting of land for South Saginaw Homes Phase I and subsequently recommended to City Council that Tentative Approval of the Preliminary Plat be granted. City Council also considered the preliminary plat and tentatively approved it. Upon this approval, the developer then proceeds with further design for the plat and coordinates with local utility providers to ensure that adequate utilities are available to service the development. After completion of this process, the developer then submits the preliminary plat along with documentation from the utility providers to the Department of Development to determine compliance with the tentatively approved preliminary plat. City Council has approved the final preliminary plat and the proprietor has proceeded with the development of the final plat. The proprietor has submitted the final plat to the City Engineer, the Planning Commission, and the City Attorney as required by City ordinance, which have all found the final plat to be in order. The last step in the platting process requires that City Council approve the final plat.

After review and consideration, City Council shall:

- (1) Approve the final plat, if it conforms to the provisions of the City ordinances and department regulations and instruct the Clerk to certify the Council's approval on the plat, showing the date of the Council's approval.
- (2) Reject the plat if it does not conform to the provisions of division (B)(1) above, and instruct the Clerk to return the plat to the proprietor, along with a copy of the proceedings setting forth the reasons.

Planning Commission Recommendation:

It is recommended that the portion of the alley bounded by Bliss St., Elm St., Gratiot Ave., and Wells St. and adjacent to the West half of Lot 5, Lot 6, Lot 7 and Lot 8 of Block Two Brockway's Addition be vacated subject to a standard easement reservation for public utilities, cable TV and telecommunications.

Justification:

Manager's Recommendation:

I recommend that the agreement with Healthy Community Partners be approved and that the City Manager be authorized to execute the agreement. This agreement is subject to approval by the City Manager as to substance and the City Attorney as to form. The cost of this agreement is \$4,700.00.

Funds are available for these services in the Department of Development Professional Services Account No. 101-3863-761-80.01

Justification:

The Department of Development has negotiated a contract with Healthy Community Partners to provide professional services consisting of development and implementation of a summer internship program which includes developing a curriculum, establishing goals, establishing learning objectives and outcomes, creating daily work schedules, monitoring work and providing guidance, assistance in managing and supervising daily activities, supervising an intern facilitated neighborhood meeting, and assisting the City in developing an accredited intern program with local colleges and universities. Healthy Community Partners has been very active in the Neighborhood Revitalization Area for 10+ years, has become a trusted resource of the residents of this community and is one of the City's partners in our Neighborhood Revitalization Program. Last year, HCP provided these services along with many others at no charge to the City, however, they did experience costs associated with this program. The Department of Development wishes to continue this relationship with

HCP, however they do not expect HCP to absorb the costs of assisting with this program. Last years program was very successful, the interns were very visible and active in the neighborhood and were very interactive with its residents helping City Hall to create a relationship and method of open communication with the residents of the revitalization area.

Because of the very specific and specialized needs of this program, no other providers of this service have been found to exist, therefore, competitive bidding was not sought in this case and the Department of Development wishes that the City Council waive this requirement.
