Manager's Recommendation

I recommend that the Council waive the potential conflict of interest present and allow the law firm of Braun, Kendrick, Finkbeiner, P.L.C. to represent Health Delivery, Inc. in its negotiation with the City for the use of Lions Park.

<u>Justification</u>

The City of Saginaw has been negotiating with Health Delivery, Inc. for the use of Lions Park, formerly Hertitage Park. Health Delivery, Inc. operates a health care facility at 501 Lapeer in the building adjacent to this small park.

Health Delivery, Inc. and the Lion's Club have been voluntarily maintaining this park and they have some suggestions for future improvements and use. Health Delivery, Inc. retains attorney Glenn L. Fitkin of the local law firm of Braun, Kendrick, Finkbeiner, P.L.C. for its counsel and wishes to use his services for this project as well. The firm has represented the City on a number of issues and continues to represent the City, all on matters unrelated to this park. Braun, Kendrick, Finkbeiner, P.L.C. and the City do not expect there to be any adverse effect to the City if it provides this representation to Health Delivery, Inc. However, Braun, Kendrick, Finkbeiner, P.L.C. is obligated by ethical considerations to obtain the City's authorization prior to proceeding.

Braun, Kendrick, Finkbeiner, P.L.C. requests that City Council confirm the City of Saginaw's waiver of the potential conflict of interest in this matter.

It was determined that an attempt to restore the server would not be practical because of its age and concerns about dependability. Documents and configurations were restored to a temporary file storage system to allow City Department's access. The server and tape system are an important piece of the City's information technology configuration and therefore require quick replacement. Informal price quotes were solicited from several vendors for price comparison purposes. The price quote from Service Express was determined to be reasonable and an emergency purchase order was created.

Saginaw and Carrollton Township. This Agreement has been approved by the City

Manager as to substance and the City Attorney as to form.

Justification:

The Water Service Agreement continues the City's policy of securing new long-

term water agreements with wholesale customers within the context of revenue sharing.

The Water Service Agreement conditions the sale of water on securing revenue sharing

agreements whereby the City will receive connection payments for new industrial and/or

manufacturing developments requiring new water mains. An additional requirement is

imposition of City income tax on new corporations having 10 or more employees and

those employees individually, which will be split on a 90%-10% basis with the Township.

The Carrollton Township Board of Trustees approved the Water Service Agreement on

October 29, 2007.

Subject: Adoption of Act 328 Resolution for Hemlock Semiconductor

Manager's Recommendation:

I recommend adoption of the Public Act 328 Personal Property Tax Abatement

Resolution for Hemlock Semiconductor Corporation.

Justification:

A resolution is listed under the regular order of business that approves the

exemption from personal property taxes for new personal property for Hemlock

Semiconductor Corporation ("HSC") under Public Act 328 of 1998, as amended. The

application was received on November 8, 2007.

In order to qualify for the exemption under Act 328, the company must be in an

eligible distressed area, be part of an eligible district and be an eligible business. The

City of Saginaw has been determined to be an eligible distressed area. The property

upon which HSC is located was transferred to the City of Saginaw for thirty years

pursuant to an Act 425 Agreement executed by the City and Thomas Township on

August 6, 2007. HSC is now part of the City and therefore in an eligible distressed

area. HSC is in an existing Industrial Development District, which is an eligible district.

An eligible business is one engaged in manufacturing, mining, research and

development, wholesale and trade or office operations. HSC qualifies as a

manufacturing operation.

The City of Saginaw has developed a policy for reviewing Public Act 328

applications considering job creation, job retention, cost of project, type of use and

percent of city residents employed. Based on the above criteria, a number of points are

assigned, which determines the number of years recommended. Using these rating criteria, the HSC application would qualify for a twelve-year abatement, the maximum normally recommended. However the policy also provides that a longer period may be recommended should other incentives be negotiated. In this case, HSC will pay substantial annual amounts in connection with the Act 425 agreement and the water availability agreements. These payments will last for thirty years, the term of the Act 425 agreement. For those reasons the Tax Abatement Review Committee recommended the approval of an Act 328 abatement for a term of thirty years.

WHEREAS, The City of Saginaw and Thomas Township have entered into an agreement for the conditional transfer of property pursuant to Public Act 425 of 1984, as amended ("Public Act 425"), for a parcel containing the manufacturing facility of Hemlock Semiconductor Corporation ("HSC"); and

WHEREAS, the City of Saginaw received from HSC an application on November 8, 2007, for exemption of new personal property pursuant to Public Act 328 of 1998, as amended ("Public Act 328"); and

WHEREAS, the City of Saginaw held a public hearing on November 19, 2007, at which time, and with advance notice, the assessor and any and all representatives of the affected taxing units were afforded an opportunity to appear and be heard on the application and exemption request; and

WHEREAS, the City of Saginaw is an eligible, distressed community under Public Act 328, and as acknowledged in the State Tax Commission Bulletin No. 9 on Exemption of New Personal Property to Assessing Officers, dated May 10, 1999; and

WHEREAS, the property upon which HSC is located is, pursuant to the provisions of the Public Act 425 Agreement, part of the City of Saginaw for thirty years; and

WHEREAS, HSC is located in a preexisting Industrial Development District, which is an eligible district pursuant to Public Act 328; and

WHEREAS, HSC meets the eligible business requirements of Public Act 328 by being engaged primarily in manufacturing; and

WHEREAS, the City of Saginaw has analyzed the Public Act 328 application by use of the Tax Abatement Review Committee, established pursuant to the City of Saginaw's Public Act 328 Policy; and

WHEREAS, the City of Saginaw and HSC intend to enter into an agreement outlining and confirming the above conditions; and

Subject: Amendment to Water Ordinance.

Manager's Recommendation:

I recommended that a subsection of Section 52.14 "Water Contracts" of Chapter 5, "Water" of Title V, "Public Works" of the City of Saginaw Code of Ordinances, O-1, be amended. The subsection to be amended and the reasons for those amendments are set out below. An Ordinance has been prepared and appears under the regular order of business.

Justification:

The City provides bulk water service to other municipalities and industrial users outside the City limits. It also provides water service to a small number of individual residences outside the City. The prior language of the ordinance required approval by City Council of any contract for water service outside the City limits. That requirement will remain for the bulk water users. The proposed change will allow the Director of Finance to regulate water contracts for the small residential users in a similar manner to that done for city customers.

A separate change addresses the problem with collection from small users outside the City limits. The City cannot place a lien on these properties and collection from tenants is less certain than collection from owners. The proposed change would require that the owner of the property enter into the water contract and become directly obligated to pay the outstanding bill.

> A) No property shall be served directly or indirectly by the City water

distribution system unless the person so served, or his or her authorized representative,

outside the limits of the City, and is for bulk or wholesale water service, such contract

shall be approved by the Council. For retail customers outside the limits of the City and

for property to be served located within the limits of the City, a contract complying with

the applicable provisions of this chapter shall be approved on behalf of the City by the

Director of Finance. Water service contracts for retail customers outside the limits of

the City shall be executed by the owner of the premises served.

Section 2. This ordinance shall become effective November 29, 2007.

Subject: Access Agreement with The Dow Chemical Company and Waiver of

Conflict of Interest

Manager's Recommendation:

I recommend approval of the Access Agreement with The Dow Chemical Company to allow it to investigate conditions on the Saginaw River and remedy them. This agreement also waives any conflict of interest in its representation by the law firm of Braun, Kendrick, Finkbeiner, P.L.C. This agreement has been approved by the City Manager as to substance and the City Attorney as to form.

Justification:

Contaminants have been discovered in the Saginaw River near Wickes Park. The Dow Chemical Company ("Dow") wants to address this problem by collecting soil and water samples and removing or properly containing hazardous materials discovered. Dow has requested access to this area through property controlled by the City. Dow will construct a temporary fence for security, store materials and equipment on the site and possibly construct or improve a road in the area. The present roadway through the area will not be blocked. The term of the agreement is one year, but Dow expects to complete the entire project within six months.

The property will be restored to the same or better condition upon completion. Dow will indemnify the City from loss and take care to protect existing utilities and provide copies and reports to the City without charge.

Dow has retained attorney Thomas Luplow of the local law firm of Braun, Kendrick, Finkbeiner, P.L.C. for this project. The City often uses this firm for other matters, and one provision of this agreement waives any potential conflict of interest with the City.
