REGULAR MEETING OF CITY OF SAGINAW COUNCIL HELD  
MONDAY, JULY 11, 2011, 6:30 P.M., COUNCIL CHAMBER, CITY HALL

Approved 6/20/11 regular Council meeting minutes.

Recognized City Manager's Executive Assistant Diane Snowden for 25 years of service.

Held public hearings and adopted ordinances vacating portion of N. Water St. bounded by Tuscola St. and E. Genesee Ave.; vacating northerly portion of N. Water St. bounded by Johnson St. and Tuscola St.; and vacating northerly portion of Tuscola Street bounded by N. Washington Ave. and N. Water St.

Held public hearing and adopted resolution establishing OPRA Certificate at 625 Owen.

Approved Petition 11-11 to erect banners at 200 Blk of W. Genesee & 1000 Blk of E. Genesee for the Saginaw African Festival.

Reappointed Elizabeth Ann Hanson to the Human Planning Committee until 7/7/2012, and appointed William Ostash to the Historic District Commission until 6/20/2014, Julie Ann Boyer and Tom Darnell to the Saginaw Arts & Enrichment Commission until 6/30/2014 and 6/11/2014, respectively.

Received and filed report from Planning Commission, Introduced Ordinance and adopted Resolution of Intent to vacate a 145' portion of the alley between 1121 Lyon St., 603, 607 and 611 South Bond St., and 608 and 612 S. Oakley St., more particularly described as the northerly 145' of the center alley of block 160, City of Saginaw in Division South of Cass St.
