REGULAR MEETING OF CITY OF SAGINAW COUNCIL HELD  
MONDAY, AUGUST 24, 2009, 6:30 P.M. COUNCIL CHAMBER, CITY HALL

Held public hearings on intent to vacate the following: a 283.91' portion of the 16' alley west of Superior between Joslin and W. Michigan; a 70' portion of an alley bounded by W. Remington, N. Harrison, W. Holland and N. Fayette; and alley located west of Grout between Joslin and W. Michigan. Adopted ordinances for each in a subsequent part of the agenda.
